Installment Plans Available

Please indicate below the payment plan you have chosen:

- Annual Installment Plan** – To be paid in full by August 1st. This plan offers a \$200/per student discount and is payable in check or cash.

- Twelve Month Installment Plan** - To be paid in 12 equal installments from June through May.

- Eleven Month Installment Plan** - To be paid in 11 equal installments from July through May.

- Ten Month Installment Plan** - To be paid in 10 equal installments from August through May.

Finance Charge/Late Payment Charge/Bank Charge

Because PCCS has a commitment to pay its bills and financial obligations on time, we encourage each family to keep their account current and up to date. Late payments and outstanding balances will be handled in the following manner:

- A finance charge of 3% will be assessed at month end to all accounts that have a balance 60 days or greater.
- A late payment charge of \$20 will be assessed if payment for tuition and/or fees is not received within ten (10) days of the date the payment is due. (Accounts are due by the 10th of the month.)
- A \$30 charge will be assessed for any checks being returned by your financial institution.
